Humanities Lecture Features Celebrated Physician

Bassett Healthcare Network is pleased to announce the inaugural David S. Svahn Humanities in Medicine Memorial Lecture. This event honors the dedication of the late Dr. David S. Svahn, a Bassett-trained resident and physician for the entirety of his 30-year career. (See the article on page 8 for more information about the establishment of this memorial which is underwritten by members of the Svahn family.)

The event features Dr. Michael LaCombe of Maine, cardiologist and storyteller. His presentation promises to be thought-provoking and entertaining. While visiting Bassett Medical Center, LaCombe will meet with residents and medical students to share his insights on medicine.

LaCombe is the author of over 100 peer-reviewed stories of medicine, and over a dozen books, including "Bedside: The Art of Medicine," a collection of fictional stories drawn from his experiences as a physician. In the book's preface, he states, "I have been a fortunate doctor, sitting as I have been in the front row of the drama of life. Here are some of the stories I have lived, stories of country medicine with lessons for the city as well." In addition to readings and lectures, theatrical performances of his stories

have been taped and used for medical training in ethics and humanism.

"It is a great honor to host Dr. LaCombe. He is the ideal speaker for this humanities presentation honoring our own Dr. David Svahn," said Dr. Kai Mebust, Chief of the Department of Medicine for Bassett Medical Center. "Dr. LaCombe's commitment to his patients and his creative writings about people in the field of medicine reflect the values of compassionate care personified by Dr. Svahn."

LaCombe has been a visiting professor at universities around the world. A retired internist and cardiologist, he is a past president of the Harvard Medical School Alumni Council and has served as an associate editor of the "Annals of Internal Medicine" for the medical humanities sections for over 30 years. He has held positions on the Board of Directors of the American Board of Internal Medicine, on the Board of Regents of the American College of Physicians, and on the advisory board of the Maine Scholar. He holds an Honorary Degree in Literature from the University of Southern Maine and is a Fellow of the Royal College of Physicians in London. ■

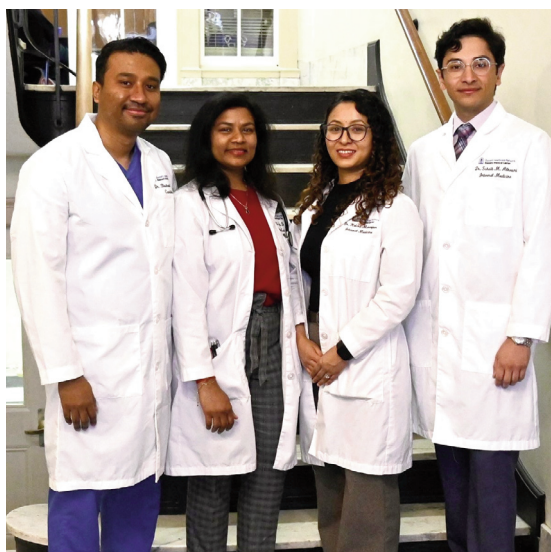

Audrey Ashley

Audrey Waite Ashley, age 98, of Kendal at Ithaca, died on March 28, 2024. She married Dr. Charles Allen Ashley in 1948. After he completed his military service as assistant chief of Pathology at Walter Reed Army Hospital, they relocated to Cooperstown where he was employed as an attending Pathologist at the Mary Imogene Bassett Hospital. In 1967, Dr. Ashley was appointed director of the Bassett Hospital. He served in this capacity until his retirement in 1984.

Together, the Ashleys were active in all aspects of the Cooperstown community. Mrs. Ashley was especially known for her efforts to extend a warm welcome to incoming hospital staff and residents. They entertained regularly in their home on the hospital's behalf. In 1999, the Ashleys moved to Ithaca, N.Y. Dr. Ashley died in 2001.

Jennifer Hecox will be attending the 2024 AHA Rural Healthcare Leadership Conference.

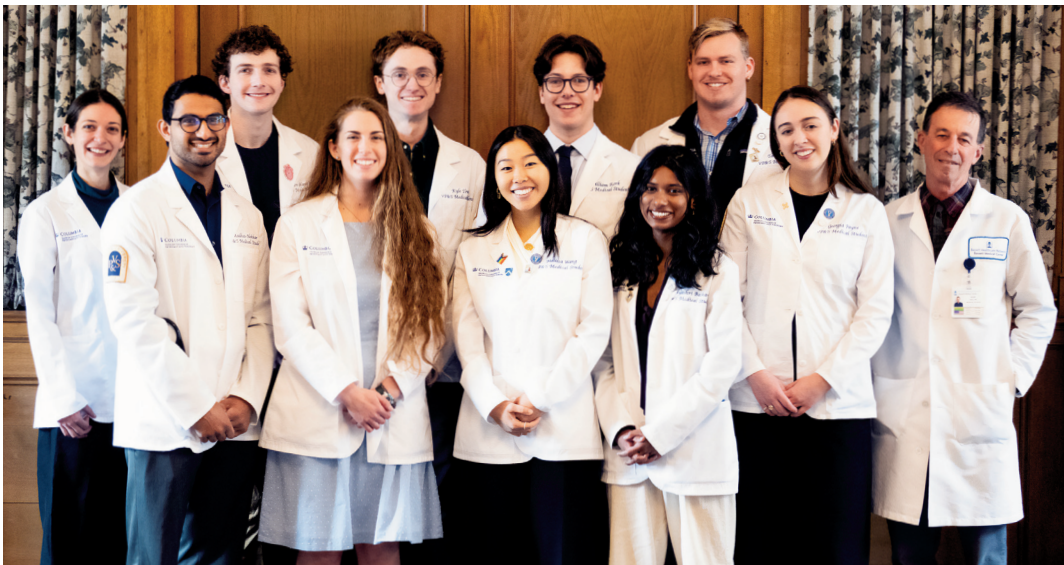

Streck's was one of the longest serving health system executives in New York State and the country and a recognized leader and innovator in health care design delivery and policy. He also served five New York State governors on advisory boards, key Department of Health committees, state policy groups, and numerous community and organizational boards—including HANYS' board of trustees—from 1988 to 2014, serving as HANYS' board chair in 2000. ■

and lead Bassett forward surrounded by a team of talented and capable leaders. I am also humbled to work alongside 5,000 amazing caregivers who are dedicated to our patients and communities."

Since taking on the role as interim President & CEO earlier this year, Thompson has clearly defined organizational priorities that focus on Bassett's financial stability, operational efficiency, recruitment and retention, continued network integration, providing exceptional patient care and experiences, embracing virtual health and innovation, and positioning the organization to thrive.

"Having served at Guthrie, a rural healthcare system that spans more than 10,000 square miles in New York and Pennsylvania, I have a deep understanding of the unique needs and challenges of rural patient populations," Thompson continued. "I am dedicated to the patients and communities Bassett serves - and to the importance of honoring its rich history and trusted position as a local, independent, community-centered network of care."

Thompson earned a bachelor's degree in biology from Gannon University in Erie, Penn. She has a master's degree in healthcare administration from Pennsylvania State University. She has served as a board member of several volunteer organizations, including United Way and Stray Haven Humane Society. Thompson was born and raised in Auburn, New York. She is married with two sons. In her spare time, she enjoys traveling, the outdoors, and volunteering. ■

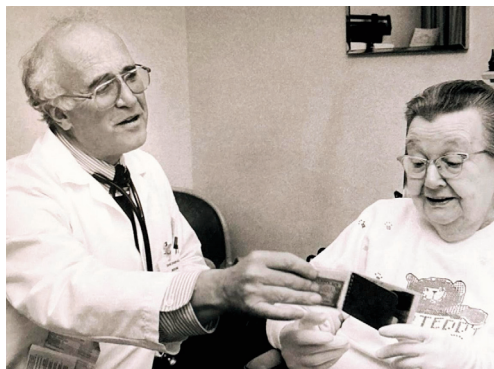
Honoring the Legacy of Dr. David S. Svahn: Embracing Humanity in Healthcare
